 - c) Are you attempting to generate an interest in Irish dancing where there was none prior to the pandemic? Or are you regenerating lost interest due to the pandemic?
 - d) Is this a one-time event, a camp of sorts, a sample class or a series of sample classes?
 - e) Apart from dancing, is there another cultural element with this project such as the Irish language?

Please note the following suggestions and ideas are encouraged:

- *Non-competitive activities and programs that highlight camaraderie / socialization / friendship, exercise, building confidence, and fun.*
- *Regional, national or international advertising that raises awareness of Irish dancing (such as a promo video that can be distributed).*
- *Festivals that include a non-competitive Irish dance element.*
- *A program appealing to the beginner 'tweenie' Irish dancer (aged 10-13).*
